4）Reportall substitutionstotheTournament Officewhensigningin．
5）Incaseofinjury，disability，oremergency afteragamehasstarted，in Teamor Doubles，asubstitutewill bepermitted ifone is available． Handicap shall be proratedaccordingtoaverages ofbothbowlersinvolved．Ifnosubstituteisavailable，thedisabled bowler＇sactual score willcountforthe frames bowled．

6）Entries will be scheduled according to requests if possible and inthe order received．The schedule will not be changed by the tournament manager except for emergencies．

7）Norefunds ofentryfees paid．Entry fee is $\$ 30$ per event．＂Late Entries＂－Entry fee for entries received day of the event is $\$ 35$ per person，per event．Optional actual prize fund available at the cost of $\$ 5$ per person．

8）Prizefees returned 100\％．Prizeswill bebasedonaminimumofnotlessthanone（1）prizeforeveryseen（7）entries．
9）Entryfees must be paid infullwith the submittal of the entryform．All Events is included in your entryfee．
